Dear Mr. Reinke:

On August 4, 1996 a 15-year old boy died in the Clements Circle Pool on Harrison Road in Livonia, Michigan. I am requesting under the Michigan Freedom of Information Act additional information about this incident. I request:

1. one copy of the Clements Circle Pool operational data and information about rescues, submersions and accidents given medical attention for the period of July 25, 1996 through and including August 6, 1996 as required by Michigan Department of Public Health (MDPH) administrative rule 325.2199.
2. one copy of the front and back side of the certificate indicating valid and current evidence of successful completion of a recognized advanced or senior lifesaving course for all lifeguards on duty during this incident as required by MDPH administrative rule 325.2198.
3. one copy of the front and back side of the certificate indicating valid and current evidence of successful completion of a recognized course of cardiopulmonary resuscitation for all lifeguards on duty during this incident as required by MDPH administrative rule 325.2198.
4. one copy of the front and back side of the certificate indicating valid and current evidence of successful completion of a recognized course of other first aid measures for all lifeguards on duty during this incident as required by MDPH administrative rule 325.2198.
5. one copy of the names and job titles for all staff including lifeguards on duty at the Clements Circle Pool on August 4, 1996.
6. one copy of the pay checks and pay check stubs for all lifeguards on duty during this incident for the period of May 1, 1996 through August 6, 1996.
7. one copy of the public swimming pool operation permit for the Clements Circle Pool as required by Michigan Public Health code 333.12527(1).
8. one copy of any order(s) closing the Clements Circle Pool for the protection of the public health and safety from January 1, 1995 to August 6, 1996 as defined by MDPH administrative rule 325.2117.

If any information is deleted, please excise the deleted material by a black-out method. If you instead use a white-out or cut-out method, please mark each deleted item on the copy. Furthermore, I expect a full and complete explanation of each deletion and the name and title of the official responsible for the decision to withhold the information.

I will expect a response to this request within five business days or less as required by the Michigan Freedom of Information Act.
