**SUMMARY:**

At 1355 hrs R/O heard a call over the radio from C.D. that Medical personnel were enroute to Saginaw High School regarding a drowning.

**INFORMATION:**

R/O responded to Saginaw High School regarding a drowning. Upon arrival, MMR had just pulled on scene and began to assist Rescue 3 from the Hess st. station. Rescue 3 had called on scene prior to our arrival and began C.P.R.

After assuring that the victim was cared for, R/O spoke to the swimming teaching (see below).

Officer Ramirez initiated a crime scene contamination sheet upon the request of Sgt. K. Revard.

After speaking with the swimming teacher I responded to the victim's address to attempt to make contact with a family member without success.

R/O obtained family information from resource Officer Terry Bracken.

After leaving the victim's residence I responded to Covenant Cooper to assist Officer McDole with matters.

R/O obtained information through medical records as to the workplace of the victim's mother. Officer McDole then called the victim's mother at work.

The victim was being treated by Dr. Carnahan and other medical staff immediately upon arrival.

At approximately 1400 hours, it was decided by the Dr. to discontinue life saving procedures.
